

### **CHANCELLOR'S WEEKEND MEMO**

The President of Western Michigan University (WMU), Dr. John Dunn, met with senior administrators to sign an agreement that will allow WMU to offer advanced classes at WCCCD's University Center. The initial WMU courses will lead to a bachelor's degree in university studies as part of a "two plus "two" arrangement. The program will allow WCCCD students to complete their associate's degree and then transfer seamlessly to WMU for the final two years of study. The WMU courses will be a combination of online and face-to-face courses. Dr. Dunn was joined by five members of his staff: Dr. Tim Greene, Provost and Vice President for Academic Affairs, Dr. Dawn Gaymer, Associate Provost for Extended University Programs, Amy Routhier, Executive Director of Enrollment Management and Marketing, Craig Boyd, Regional Coordinator and Michael Mathis. A partnership with an institute of the caliber of WMU only enhances the mission of WCCCD to provide pathways for WCCCD students to a better life through higher education.

- Time-to-Adoption Horizon: Two to Three Years Augmented Reality, Game-Based Learning, The Internet of Things, Learning Analytics
- Time-to-Adoption Horizon: Four to Five Years 3D Printing, Flexible Displays, Next Generation Batteries, Wearable Technology


#### **CONGRATULATIONS LOURIE DAVIS!**

## Student Refund Checks

The Bursar's Office is in the process of completing the check audit for the first financial aid disbursement for Spring 2013. Student refund checks will be placed in the mail within 14 days of the disbursement date. It is extremely important for students to verify their mailing address and make adjustments as appropriate in order to prevent delays in receiving their residual disbursements. Students may visit any campus location to make adjustments and complete the address change documentation.



## 2012 W2's Have Been Mailed

2012 W2'S are now available. Hard copies were mailed on January 29th and electronic copies can be accessed from Web-Gate 24/7.

#### Please note:

When reconciling W2 wages against year-to-date wages from paystubs, pre-tax deductions need to be taken into consideration. In order to arrive at the Federal wage base in box 1:

Pre-Tax Deductions: Subtract healthcare premiums, tax sheltered annuities and any retirement benefits from year-to-date wages from the last paystub.

Add back the taxable value of employer provided group-term life insurance, which can found in box 12 code C, to year-to-date wages from the last pay stub.

### NURSING PROGRAM ACCREDITATION UPDATE





The National League for Nursing Accrediting Commission (NLNAC) provides a common core of standards and criteria for the accreditation of nursing programs. The six standards are designed to strengthen educational quality. **Standard 5** assesses the fiscal, physical, and learning resources which promote the achievement of the goals and outcomes of the nursing program. This standard explores such areas as: the sufficiency of fiscal resources to achieve nursing program outcomes; the adequacy of learning environments (classrooms, labs, offices, etc.) to meet the needs of faculty, staff and students; and the comprehensiveness and currency of learning resources. Why is accreditation important? Accreditation assists a nursing program to determine how well standards are achieved. Using this assessment a nursing program can improve courses, strengthen curricula and build a lasting foundation of quality education for nurses.

Dr. Debraha Watson and Johnesa Hodge provided a presentation to nursing administration and faculty on District alignment with campuses and programs. Topics of discussion included the Annual Planning Cycle, the Budget Development and Allocation Process for the District and how this information addresses NLNAC Standard I-Mission and Administrative Capacity.

#### **INSTITUTIONAL EFFECTIVENESS**



The New Graduate Exit Survey is designed to capture new graduates immediate perceptions of their overall academic and student life experiences upon degree completion from WCCCD.



This survey is administered annually during the commencement ceremony and graduation application process to ensure proper feedback about student experiences and plans following graduation.

Some key findings are:



- 84.5% of the respondents indicated a WCCCD education has helped them in pursuing further education
- ♦ 73.4% of the respondents reported working intermittently to full-time during their program of study
- Students rated Quality of Instruction and the Bookstore as the top areas of satisfaction
