

Dental hygiene students volunteered at the Taylor Northeast Little League helping to clean up the baseball fields for spring play.




## Division of Administration and Finance

Due to new federal Department of Education regulations,he following changes will be put in place by Higher One on or before July 1, 2016:

- ALL Higher One card fees will be eliminated except for the foreign ATM fee (\$2.50), and a lost card fee of \$10. All other costs will be eliminated including overdraft and NSF (non-sufficient funds) fees.
- Students will have access to 55,000 ATM's nationwide for FREE, many allowing for cash back options.
- Checks can now be ordered for FREE.
- A new temporary turn-off feature will be available if you lost your card.
- Higher One cards will only be sent upon student request. Initial letters to students will only
  include a code for accessing the website and direct deposit will be the encouraged choice for
  students.

There are now 11,987 students who have opened a One Account. These students are increasing their financial literacy and accessing their funds through the latest technology advancements.

#### **ELLUCIAN BANNER TRAINING**

As part of ongoing professional development, WCCCD is bringing a training consultant from Ellucian to conduct a comprehensive Banner training session to cover all functional areas of the Banner modules including Student Services, Human Resources, Financial Aid and Finance and Administration. 
# What can you do to protect yourself and your organization from such malicious attack?

# WCCCD Compliance Reporting and Beyond

WCCCD continues to show their improvement as a best practice institution by collecting data. The Office of Accountability and Transparency works with the Continuous Quality Improvement Team to review institutional audits and compare their findings to our internal controls. The findings position the District to make appropriate internal control adjustments. Current discussions include the following reviews of both community colleges and universities:


- Grant compliance signature certifying report




# Downtown Campus President's Initiative Author Series

## Legislative Corner

#### **Water Crisis Forum**

Michigan State Representatives Garrett and Chang hosted a forum on the Downtown Campus about the water crisis going on throughout Michigan.





### Michigan New Jobs Training Program

The House Workforce and Talent Development Committee reported out on House Bills 4750 and 4751, which would create a parallel Michigan New Jobs Training Program operated by ISDs. Importantly, the Committee adopted amendments for both bills that would limit the program to ISDs whose service area lies at least 50% outside a community college district.

#### FY 2016-2017 Budgets Move

The House Appropriations Committee reported out on House Bill 5291, the omnibus appropriations bill for schools, community colleges, and public universities. While the bill was reported out along party lines, mostly due to concerns with the K-12 and university portions of the bill. The Committee did not make any changes to the subcommittee recommendation for community colleges, which had increased the bump in operations funding to an average of 3.4%.

#### Department of Labor Expected to Release New Overtime Rule

Last summer, the Department of Labor issued a Notice of Proposed Rulemaking (NPRM) on redefining which workers are protected by minimum wage and overtime standards. The proposal more than doubles the minimum wage threshold for exempt employees. The rule is in its final stages. If the final rule emerges largely unchanged from the NPRM, there could be significant financial costs for some colleges.

# AACC Urges Congress to Reinstate Year-Round Pell

The American Association of Community Colleges is asking its members to contact their congressional representatives and urge them to reinstate the year-round Pell Grant (YRP), using the program's current surplus. year-round.
